

**CITY OF XENIA, OHIO
ORDINANCE 2021 – 04**

**AMENDING SECTIONS 298.01, 238.02(b), 618.02(f), 1040.05(b), AND 1046.03(a)
AND REPEALING CHAPTERS 808., 820., 1054., 1440., AND 1468. OF
THE CITY OF XENIA CODIFIED ORDINANCES**

WHEREAS, it is important for the City to review the fees for its various services and permits from time-to-time;

WHEREAS, after a thorough review, City staff has recommended changes to the City’s Fee Schedule to delete obsolete fees, simplify the fee schedule, and update those fees that need to be adjusted; and

WHEREAS, this Council finds it to be in the best interests of the health, safety and welfare of the City to make the requested amendments to the City’s Fee Schedule and repeal those Chapters of the Codified Ordinances that are no longer needed or relevant.

NOW, THEREFORE, THE CITY OF XENIA HEREBY ORDAINS, at least four (4) members of the City Council concurring, that:

Section 1. Chapter 298., specifically Section 298.01, titled “Fee Schedule” of Part Two – Administration Code, Title Twelve: Fees, of the Codified Ordinances of the City of Xenia is hereby amended, as shown in the attached Exhibit A.

Section 2. Division (b) of Section 238.02, titled “Public Safety Director,” of Part Two – Administration Code, Title Six: Administration of the Codified Ordinances of the City of Xenia; Division (f) of Section 618.02, titled “Running at Large; Dangerous and Vicious Dogs,” of Part Six – General Offenses of the Codified Ordinances of the City of Xenia; and Division (b) of Section 1040.05, titled “Failure to Pay Utilities Bill; Shut-Off Notices and Surcharges,” and Division (a) of Section 1046.03, titled “Description of Service Charges,” of Part Ten – Streets, Utilities, and Public Services Code, Title Four: Utilities, of the Codified Ordinances of the City of Xenia, are hereby amended as shown in the attached Exhibit B.

Section 3. Existing Sections 298.01, 238.02(b), 618.02(f), 1040.05(b) and 1046.03(a) are hereby repealed.


Section 4. Chapter 808., titled “Cable Communications,” and Chapter 820., titled “Escorts and Escort Services,” of Part Eight – Business Regulation and Taxation Code, Title Two: Business Regulation of the Codified Ordinances of the City of Xenia; Chapter 1054., titled “Water and Sewer Extension Projects,” of Part Ten – Streets, Utilities, and Public Services Code, Title Four: Utilities of the Codified Ordinances of the City of Xenia; and Chapter 1440., titled “Administration, Permits, and Fees,” and Chapter 1468., titled “Moving of Buildings,” of Part Fourteen – Building and Housing Code, Title Four: Miscellaneous Building Regulations of the Codified Ordinances of the City of Xenia, all as shown in the attached Exhibit C, are hereby repealed in their entirety.


Section 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Ordinance shall be effective on March 13, 2021.
